

BID NOTICE

The Plum Creek Conservation District (PCCD), Lockhart, Texas is requesting sealed bids from qualified, responsible bidders for REHABILITATION to Floodwater Retarding Structure Site 28 at Lower Plum Creek Watershed in Caldwell County, Texas.

One award for all items will be made. Performance time is 837 calendar days. Estimated price range is between \$9,000,000 and \$13,000,000. Major items of work are: 9,615 LF fence removal; 7,436 LF silt fence; 91.0 Acre sprigging; 1 irrigation system; 18,532 1000-Gal irrigation water; 69,705 CY common embankment excavation; 72,389 CY unclassified right auxiliary spillway excavation; 106,739 CY standard earthfill; 2,337 CY drainfill; 203,145 SY topsoiling; 1,848 LF diversions; 66.4 CY structural concrete; 38.1 CY pipe cradle concrete; 9,711 Lb. reinforcing steel; 180 LF 30" C-301 concrete pressure pipe; 24 LF 24" C-301 concrete pressure pipe; 2,855 LF 6" I.D. PVC plastic pipe; 84 LF 4" I.D. PVC plastic pipe; 20 LF ductile-iron pipe; 7,762 Ton rock riprap; 95.3 LF chain link fence; 10,019 LF barbed wire fence; 9,117 SY geotextile; and 1 Job, lump sum each for clearing and grubbing, principal spillway removal, pollution control, construction surveys, mobilization and demobilization, removal of water, surface repair/treatment of existing concrete, 12" dia. opening slide gate; principal spillway metal work, and contractor quality control.

PCCD reserves the right to accept or reject any and all bids. A 5 percent bid guarantee is required. The successful bidder will be required to furnish performance and payment bonds.
